- b) There shall be no form fee for the services being offered through the existing online/across the counter service delivery channels e.g. Suwidha Centers.
- c) The forms for these services will be made available on Punjab State Portal i.e. <a href="www.punjab.gov.in">www.punjab.gov.in</a> for free downloading. The forms for these services shall not be sold at existing Suwidha Centers to the citizens. Printed forms shall also be made available at Suwidha Centers.
