Order No. 268 /MA

Whereas COVID-19 has been declared Epidemic by Government of Punjab as well as Govt. of India and the Virus is spreading out very quickly. To stop spreading of COVID-19, the Curfew was imposed Under Section 144 of the Code of Criminal Procedure, 1973 vide order No. 212/MA dated 23.03.2020 issued vide Endst. No.1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot with effect from 23.03.2020.

To stop the COVID-19 spread there is an urgent need of identification of slum/congested areas where the disease may spread. The first step of breaking the chain of infection is identification of such hotspots.

In this context a meeting was called (minutes of meeting attached) to formulate a strategy for breaking the infection chain of COVID-19. The first main step for breaking the chain is early identification of hotspots. The officers of Urban Local Bodies have identified the following habitation in territorial jurisdiction of District Faridkot as congested and contiguous habitations regarding which Civil Surgeon recommended strict enforcement of quarantine norms.
