

Order No. 228/MA

The Curfew was imposed Under Section 144 of the Code of Criminal Procedure, 1973 vide order No. 212/MA dated 23.03.2020 issued vide Endst. No.1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot with effect from 23.03.2020 (14.00 Hours).

In continuation to Order No. 227/MA dated 24.03.2020, issued vide Endst. No. 1606/MA dated 24.03.2020 M/s Arora Service Centre, Talwandi Road, Faridkot is hereby ordered to be opened today w.e.f. 24.03.2020 (06.00 PM) to 25.03.2020 (08.00 PM) to cater the POL to Govt. Vehicles, Ambulances, Vehicles on Curfew duty, any person coming with Curfew pass and the Press/Media persons only.

The Petrol Pump owner/dealer shall be responsible to follow the instructions/orders issued by Govt. of India/Govt. of Punjab and undersigned regarding the COVID-19. The petrol pump owners while operating their pump will ensure that costumers coming to their pumps should maintain SOCIAL DISTANCE (1.5m to 2.0 m) to avoid spread of COVID19. Any violation of these instructions/orders is liable to criminal prosecution. SSP, Faridkot will provide necessary security at the above mentioned Petrol Pump sites
