Order No. 281 /MA


The Curfew was imposed vide order No. 212/MA dated 23.03.2020 issued vide Endst. No. 1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot.

Whereas in pursuance of the letter no. SS/Home/Spl dated 29.03.2020 of the Additional Chief Secretary Home, Government of Punjab and Letter Memo no RBI/20120/194 DGBAGBD No 1799/42.01.0269/2019-20 dated 27.03.2020 issued by Reserve Bank of India the following instructions are issued:-

1. All the Branches of District Faridkot including the controlling office/back office are to be opened on 30.03.2020 and 31.03.2020 with minimum staff .
2. The Time duration for the Branches will be from 11.00 AM to 4.00PM and for controlling/administrative office will be 10.00AM to 5.00 PM.
3. All the ATMs of every Bank shall remain open from 09.00AM to 06.00PM.
4. The Branches will be opened for essential services from 11.00 AM to 02.00PM. All the banks should keep their designated branches open for over the counter government transactions upto the normal working hours of Banks.
5. The identity card of the staff will be treated as the curfew pass.
6. BC/CSP's of all the Banks are allowed to provide services at there service points/allotted villages. BDPO's are requested to instruct village authorities to support BC/CSP's and they should ensure social distancing and other precautionary measures.
7. Taking into account the curfew imposed in the District, Police Personnel should be deployed at each branch/ATM to handle or control rush of customers.
8. All the managers of the banks which will be opened during this specified time are directed to ensure all the social distancing and personal hygiene measures in their branches i.e maintaining 1 to 1.5 meter distance, use of sanitizers, masks and gloves by the staff, at the branches and ATMs.

From 1st April,2020 Bank Timings will be as per the Order no 263/MA dated 27.03.2020
