ORDER NO.- 398

Registrar Co-operative Societies, Punjab, Chandigarh vide Letter no. RCS/Mkg/Spl-1 dated 30.03.2020 has written that GOI has allowed the movement of fertilizers to facilitate its supply for the next crop. In the State of Punjab, nearly 6 Lakh MTs of Urea and 54,000 MTs of DAP is required to be supplied through the network of the cooperative societies. So far only 25% of the above quantity of fertilizers has been stored in cooperative societies. Hence the incoming rakes of the fertilizer have to be handled for loading, unloading and onward transportation to the concerned Societies without compromising the norms of social distancing.

In pursuance of the above-said letter of Registrar Co-operative Societies, Punjab, Chandigarh, the following committee is allowed to be constituted in District Ferozepur:-

1. Deputy Registrar, Cooperative Societies, Ferozepur- Chairman.
2. District Manager, Markfed, Ferozepur – Convener (In case of Markfed rakes).
3. District Manager, IFFCO, Ferozepur – Convener (In case of IFFCO rakes).
4. Agriculture Officer concerned- Member.
5. Block Development and Panchayat Officer (BDPO) of the concerned area-Member.

The BDPO concerned will enable to rope in the labour under MGNREGA for this purpose. BDPOs are directed to coordinate with concerned Deputy Registrar, Co-operative Societies to take the demand for supply of MNREGA workers. BDPOs shall ensure that the MGNREGA workers follow strictly the protocol of social distancing and sanitation using masks, soap and sanitizer frequently.

This order shall become operational with immediate effect.
