
The Curfew was imposed vide order No MC-1/MA 2020/4370-92 dated 23-03-2020 in territorial jurisdiction of District Fazilka,

Whereas in pursuance of the letter No. SS/Home/Spl-2 dated 29.03.2020 of the Additional Chief Secretary Home, Government of Punjab and Letter Memo No. RBI/20120/194 DGBAGBD No.1799/42.01.0269/2019-20 dated 27.03.2020, issued by Reserve Bank of India, it is necessary to amend the order vide No. 5076-96/MC-3/MA dated: 26.03.2020, vide No. 5176-88/M.C.3/M.A dated: 27.03.2020 and order No. 5216-37/MC-3/M.A. dated 29.03.2020., issued by this office, therefore the said orders issued by this office stand amended as under:-

1. All the Bank Branches, ATMs, BCs (Banking Correspondents), Cash in transit/Cash replenishment agencies/Cash Vans, IT and engineering support vendors for Banks shall be operational on 30.03.2020 & 31.03.2020 with skeletal staff. Since 1st April 2020 is a non-public dealing day for the banks, there shall be no public dealing in the bank branches. The working hours for these days, shall be 10.00 AM to 5.00 PM.
2. Taking into account the curfew imposed in the district, Police Personnel should be deployed in each branch/ATMs to handle or control rush of customers.
3. The Identity Cards of the Banking Staff will be treated as the Curfew pass.
4. All the Managers of the bank allowed to open during this specified time are directed to ensure all the social distancing and personal hygiene measures in the branches i.e. maintaining 1 to 1.5 meter distancing, use of sanitizers, masks & gloves by the staff at the branches and ATMs.

This order shall become operational with immediate effect.
