ORDER

Ref. No. 814/MA

WHEREAS, in exercise of power conferred under section 144 of Cr.P.C. curfew has been imposed in the District till further orders vide Order No 813/MA dated 23.03.2020 for the prevention and containment of spread of **COVID-19**.

WHEREAS, to maintain essential commodity supplies and bona-fide movement of goods and persons carrying these Goods for distribution shall be allowed in the whole district of Fatehgarh Sahib. The list of Goods and services are as follows:-

1. Milkmen and Dairy owners are allowed production, door to door distribution and delivery of milk. They shall be allowed to operate from 7:00 AM to 9:00 AM. They will ensure hygiene and follow the protocol regarding safe distancing while dealing with customers.
2. For supply of vegetables, Rehris and Shops shall be allowed to operate on the condition that they will sell vegetables and groceries in form of home delivery, door to door during 4:00 PM to 6:00 PM. No grocers shall open their shops for sale over the counters. On Condition that they get passes issued by District Magistrate or any other officer authorized by DM/ADM. DMO and DFSC through their Market committee secretaries and inspectors will ensure the free movement of these services. They will also ensure there is no over pricing and black marketing of grocery items.
3. Gas Agencies shall be allowed to operate in the District Fatehgarh Sahib Conditions that they will ensure Home delivery to the customers on their request between 1:00 PM to 3:00 PM only. On Condition that they get passes issued by District Magistrate or any other officer authorized by DM/ADM. DFSC to ensure their smooth operation & movement.
4. Petrol pumps shall be allowed to operate in the District Fatehgarh Sahib from 8:00 AM to 11:00 AM. On Condition that they get passes issued by District Magistrate or any other officer authorized by DM/ADM. DFSC, Fatehgarh Sahib to ensure smooth supply of petroleum products on ration basis.
5. Chemist shops shall be allowed to operate for Door to Door delivery of medicines to the customers on their request. No chemist shall open their shops for sale over the counters. Drug inspector to ensure there is no over pricing and black marketing of drugs, including the passes from DM/ADM.

WHEREAS to maintain Emergency, other services & operations.

Following shall be allowed to operate:-

1. Movement of vehicle carrying Animal fodder, Poultry Livestock, Poultry food, food grain, milk, grocery items, petroleum products, LPG shall be allowed to operate, SSP, Fatehgarh Sahib and All SDMs will ensure inter and intra district movement of all such vehicles.
2. Electricity generation, transmission and distribution services and uninterrupted supply of power.
3. Govt. Employee tasked with law and order/emergency services, duties including executive magistrates, police personnel, military/paramilitary personnel in uniform, health, government machinery tasked with **COVID-19** related duties and essential services shall be allowed to attend duty on production of their Official ID cards.
4. Govt. Employee of non emergency departments, but on official essential duties shall be allowed upon production of valid Duty Pass signed by Executive Magistrate designated for the purpose

by undersigned. 


5. Health service personnel such as Doctor, Nurses, Pharmacist and other professional medical services shall be allowed to attend duties on production of ID cards from their respective government institutions.

For private clinics, hospitals and nursing homes in District Fatehgarh Sahib shall be allowed to provide medical and surgical emergency care to public and will maintain strict preventive protocols against **COVID-19**. Emergency staff shall be allowed to attend the duties by showing their ID cards. No private hospital, clinic or nursing home shall be allowed to carry out routine OPD and Elective surgeries.

6. Media persons with accreditation and recognition (Pink and Yellow cards) issued by the Government.
7. Critical Telecom Infrastructure including Telephone Exchange, Mobile Switching Centres, Network Operation Centers, Transmission Centre, Data Centers, Telecom Tower Sites, Call Centers of Telecom service providers and ware houses where spare parts of telecom services providers are stored; including their manning, movement to and from these facilities of their staff. The service providers shall get the curfew pass of their respective staff issued by District Magistrate or any other officer authorized by DM/ADM.
8. Critical railway infrastructure required for smooth functioning of goods train. Railway staff involved in maintenance and running of railway infrastructure would be allowed to operate on production of their official ID cards.

These institutions/Individuals/Officers/employees will follow the instruction/orders issued by Govt. of India/ Govt. of Punjab and undersigned regarding the **COVID-19**.
