Relaxation in CURFEW ORDER REGARDING SMOOTH FUNCTIONING OF BANKS

Whereas curfew orders under the Rule 12 of The Punjab Epidemic Diseases COVID-19 Regulations 2020, was imposed by undersigned to prevent and contain spread to corona virus disease vide order No. M.C.1/M.A./2020/4370-92 Dated 23.03.2020 thereafter relaxations given by letter No. 5276-96/M.C-3/M.A. Dated:26.03.2020, whereas now in partial modification to the aforesaid orders, I hereby give relaxations subject to following terms and conditions.


1. One branch of every bank or as decided by Lead Bank Manager, Fazilka shall remain open in Urban/Sub urban area with skeleton staff.
2. The Lead Bank Manager, Fazilka is also authorised to prepare the list of banks operating in rural area, for which he will prepare a roster of these branches on certain days of the week with skeleton staff only.
3. Working hours of these branches be specified for three hours only from 11:00 AM to 02:00 PM for the normal working days.
4. The open branches will carryout only cash transaction (Receipt and payments) remittances, Govt. transactions and clearing functions relating to the essential services as per my earlier order letter No. 5276-96/M.C.3/M.A. Dated :26.03.2020.
5. To fulfill cash requirements currency chest to remain open.



All the managers of banks which will be opened during this specified time are directed to ensure that the social distancing and personal hygiene measures in their branches i.e. 1 to 1.5 metre distances, use of sanitizers, masks and gloves by the staff at all the branches.

The following categories of employees/staff shall be permitted to travel/transit:-


- a. Employee staff of banks.
- b. Cash logistic/cash in transit companies/employees.
