In Continuation of this office order No. 5176-BB/M.C.3/M.A. Dated. 27.03.2020, the said order is slightly amended as under:-

All the Multipurpose Primary Co-operative Agriculture Service societies limited and all the Co-operative Banks branches of The Fazilka Cooperative Bank Limited, Fazilka are allowed to open in curfew period from 11:00 AM to 02:00 PM to cater the needs of the members of the Multipurpose Primary Co-operative Agriculture Service Societies Limited. Such personnel will move along with certified Id-cards, which should be treated as curfew passes. The Multipurpose Primary Co-operative Agriculture Service Societies Limited will make only home deliveries of goods to their members. The employees of the societies are allowed to visit their respective Co-operative Bank branches for banking purpose. D.F.S.C., Fazilka will ensure supply of essential commodities to The Multipurpose Primary Co-operative Agriculture Service Societies Limited. The District Manager, Markfed Fazilka will ensure the supply of cattle feed to The Multipurpose Primary Co-operative Agriculture Service Societies limited. The employees of The Co-operative Societies and Co-operative banks will strictly follow the protocol of social distancing and sanitation using masks, soaps and sanitizers frequently.

Further, all the Business Correspondents (BCS) attached with the different banks are advised to provide their services to the customers as and when required. The working hours of the BCS shall be 11:00 AM to 02:00 PM. The Id Cards issued to them by banks shall work as their curfew pass.

The list of BCS working in different areas is attached herewith.
