ORDER

WHEREAS, in exercise of power conferred under section 144 of Cr.P.C. curfew has been imposed in the District till further orders vide Order No 813/MA dated 23.03.2020 for the prevention and containment of spread of COVID-19.

WHEREAS, to maintain supply of essential commodities and bona-fide movement of goods and persons carrying these goods for distribution were allowed in the whole district of Fatehgarh Sahib vide order No. 814/MA dated 25.03.2020. As per the directions of Government of Punjab received vide D.O. letter No. 1/2020/NRES/SPL-1 dated 27.03.2020, vide memo No. PA/Spl/Input/102 dated 27.03.2020 and advisory received on 28.03.2020 following services are also exempted through this order as follows:-

1. Free movement of Farm operation machinery including Combine Harvesting machinery and transport vehicles for carrying the farm produce.
2. Permitting free movement of farmers and farm labour for farming operations of harvesting and sowing.
3. Operation of custom hiring centers related to farm machinery in cooperative and private sector.
4. Operation of flour mills for supplying flour.
5. Permitting the sale of seeds, fertilizers, insecticides and pesticides from 11 AM to 2 PM.
6. Permitting preparation of marketing yards for wheat arrivals.
7. Any operation related to procurement of wheat by Government procurement agencies.
8. Any operation related to supply of Wheat/Rice for PDS (Public Distribution System) under NFSA. DFSC, Fatehgarh Sahib is hereby authorized to issue passes for free movement of vehicles.
9. Operation as Renewable Energy Generating Stations (REGS) including Solar Power Plants, Small Hydro Power Plants, Biomass/Biogas/Co-generation based power plants etc.
10. Permission for REGS staff, associated work force and vehicles to move around and movement of material and field engineers at REGS sites on production of official ID cards.

All those individuals/institutions exempted will ensure to adhere to social distancing and personal hygiene measure i.e. maintaining 1 to 1.5 meter distance, use of sanitizers, masks and gloves etc.
