The medical store owners shall be responsible to follow the instructions/orders issued by Govt. of India/Govt. of Punjab and undersigned regarding the COVID-19. All the medical store owners while operating their shops and supplying medicines to home should maintain **SOCIAL DISTANCE (1.5m to 2.0m)** to avoid spread of COVID19. All the medicines must be delivered without any delivery charges and not more than MRP. Any violation of these instructions/orders is liable to criminal prosecution. The order is being issued in the interest of general public, in case there is any complaint regarding the supply of grocery items, the complaint may be lodged at COVID 19 control room no. 01639-250338, 256060. Control room is directed to elevate the complaint to Sector Magistrate/SDM depending upon its urgency.
