Order No. 286 /MA

The Curfew was imposed Under Section 144 of the Code of Criminal Procedure, 1973 vide order No. 212/MA dated 23.03.2020 issued vide Endst. No.1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot with effect from 23.03.2020 (14.00 Hours).

Whereas in pursuance of the letter no. PA/Spl/input/103 dated 27.03.2020 of the Secretary, Government of Punjab, Department of Agriculture Finance, imposition of curfew/lockdown the procurement operation cotton has come to stand still, farmers shall face an imminent loss if the cotton crop is not procured immediately. The Cotton Corporation of India (CCI) requested to open their branches and centres for making payment to the farmers. They have allotted their centre in Jaitu Sub-Division, District Faridkot.

Where as now to ensure supply of basic services to citizens following relaxations/exemptions, the Employees of the Cotton Corporation of India (CCI) Centre Jaitu Sub-division, District Faridkot are allowed for continuing the procurement of cotton, payment to farmers and processing/transportation of unginned kapas/seed with the following conditions:-

- a. They will follow the above curfew order and norms of social distancing and will follow safe hygiene practices.
- b. These exemptions are applicable only on production of I-card issued by their department.
This order shall take effect at once.
