Order No. 34//MA

The Government of Punjab notified a Curfew in the territorial jurisdiction of the entire state of Punjab in public interest until 30, April, 2020 accordingly the Curfew under Section 144 of the CrPC, 1973 was imposed in District Faridkot for prevention and containment of the spread of COVID-19. To prevent the spread of Coronavirus (COVID-19) and other infectious diseases dangerous to life, it is expedient in the interest of public health to prohibit production, manufacture, import, export, transport, sale distribution, storage, advertisement and use of smokeless tobacco, pan masala and the like products which induce or encourage splitting or its use in District Faridkot as it increase the incident of Coronavirus spread.

Whereas production, manufacture, import, export, transport, sale, distribution, storage, advertisement and use of smokeless tobacco, pan masala and the like products which induce or encourage splitting or its use, results in causing public nuisance and spread of infection of disease dangerous to life and is therefore a punishable offence under section 268, 269, 270 of the Indian Penal Code.

Therefore, I, Kumar Saurabh Raj, IAS, District Magistrate, Faridkot in exercise of the powers conferred upon me under section 144 of the CrPC, 1973 do hereby prohibits production, manufacture, import, export, transport, sale, distribution, storage, advertisement and use of smokeless tobacco, pan masala and the like products which induce or encourage spitting or its use and spread of dangerous and epidemic disease in the territorial. Any violation of this order shall entail strict action under section 188, 268, 269 and 270 of the Indian Penal Code.

This order shall be promulgated by the beat of drum in the villages and towns of the district and also through the Public Relation Department and by affixing copies of this order on the notice boards of the offices of the Deputy Commissioner/Senior Superintendent of the Police/Sub Divisional Magistrates/ Tehsildars and Naib Tehsildars/BDPOs/Gram Panchayats/ EOMC's within the district and at other conspicuous places.


