Order No. 349 /MA

Whereas, Curfew was ordered to be imposed vide this Office Order No. 212/MA dated 23.03.2020, issued vide Endst. No. 1587/MA dated 23.03.2020 in the territorial jurisdiction of District Faridkot till further orders.

Whereas, in District Faridkot curtains exemptions from time to time were granted by this office as per guidelines/instructions issued by Govt. of India as well as Govt. of Punjab.

Whereas, as per para 4 of the guidelines/instructions issued by Ministry of Home Affairs, Govt. Of India vide letter No. 40-3/2020-DMH (A) dated 15" April 2020 states could impose stricter measures than these guidelines, as per requirements of local areas.


Now therefore, **I Kumar Saurabh Raj, IAS, District Magistrate, Faridkot** by virtue of the power vested in me under section 144 of the Code of Criminal Procedure, 1973 hereby order that keeping in view the emergent nature and potential magnitude of the pandemic and for the purpose of ensuring health and safety of human life by enforcing stricter measures- the curfew imposed in the district shall remain in force. Operation of any additional activities/offices/establishments (not already allowed under previous orders/exemptions) shall not take place without specific exemptions granted by this office, which shall be determined on the basis on the objectives of essential nature of the activity, the mitigation of hardship to the public and ensuring continuity of Government business.

Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 and Indian Penal Code, 1860.
