OFFICE ORDER

Whereas, COVID 19 has been declared as a pandemic by the National Disaster Management Authority vide Order No. 1-29/2020-PP(Pt. II) dated 24.3.2020 under The Disaster Management Act 2005,

Whereas, in view of the emergent nature and potential magnitude of the pandemic there is a need to immediately put in place adequate measures for proper isolation and medical care of COVID19 positive cases in the district and to prevent further spread in the community, and



Whereas the public health infrastructure in the district is inadequate to cope with the large number of COVID patients who will require isolation given the potential magnitude of the pandemic. The District Authority needs to augment the available infrastructure for isolation of COVID affected patients.

Therefore, in pursuance of the provision of Section 34 of the Disaster Management Act, 2005 it has been decided to notify,

1. PUNJAB MULTIPURPOSE MEDICAL INSTITUTE VILLAGE SEHNA
2. GURU GOBIND SINGH COLLEGE OF NURSING BARNALA

as COVID CARE CENTRES in public interest to provide relief to the residents of this district with effect from 21-04-2020.

This order shall remain in force for a period of three months from the date of issue and can be extended in case of continuation of the pandemic.
