OFFICE ORDER

Brick Kiln Association of District Barnala has requested that they are running Brick Kilns continuously. But now it is not possible for them to manage the funds for labour. The said Association has further requested that as per the notification of the Central Govt., all Brick Kilns are to be operated from 20/04/2020. The said Association has requested that they may be allowed to supply the bricks to customers.

This request is in consonance with clause 13(i) and 15 (xi) of the consolidated Revised Guidelines issued by Ministry of Home Affairs (MHA) vide Order No. 40-3/2020-DM-I(A) Dated 15/04/2020. Therefore, permission is hereby granted to Brick Kilns in rural areas to supply bricks to the customers in territorial jurisdiction of District Barnala, provided that existing instructions regarding social distancing and hygiene by wearing masks, gloves and using sanitizer and washing hands frequently and all other instructions issued by Home Department/Health Department shall be strictly complied with. Curfew passes will be issued by this office for labourers (1 Driver and 2 Labourer for each kiln) to the Assistant Labour Commissioner, Barnala at Sangrur who will further issue these curfew passes to the said labourers, by name, maintaining a complete record. The following vehicles are allowed to ply for supply of bricks to the customers:-
