No. 5713-99 dated 23-3-2020 vide which restrictions on movement of any person outdoor (curfew) from 23-3-2020 (2.00 PM) till further orders.

Bansal Milk Chilling Centre Private Limited and SMC Food's Limited, Jeewan Singh Wala has requested that permission to collect milk from small dairy farmers may be given to them as farmers are not able to sell this perishable product.

As milk is a perishable item and keeping in view the interest of small dairy farmers Bansal Milk Chilling Centre Private Limited and SMC Food's Limited, Jeewan Singh Wala is allowed to collect the milk from dairy owners/ farmers on their own vehicles.


