
OFFICE ORDER

In order to break the transmission chain of contagion of COVID-19, undersigned has issued prohibitory orders under section 144 of the Code of Criminal Procedure, 1973 vide endst. No. 5713-99 dated 23-3-2020 vide which restrictions on movement of any person outdoor (curfew) from 23-3-2020 (2.00 PM) till further orders.

WHEREAS, in pursuance of the letter No. FD/IF/2020/SPL/1 dated 24-3-2020 issued by Department of Finance, Govt. of Punjab and in continuation to this office Order no. 678/CMC dated 28-03-2020, Order no. 700-13 dated 30-03-2020 and Department of Home, Punjab Govt. order no. SS/Home/SPL Dated 29-03-2020 following institutions, LDM Office Staff, Banks, CRA & CIT Agencies/IT and engineering support vendors for bank(s), officers, employees from local and nearby districts, with their Vehicle, on production of their Official Identity Cards are exempted from the restrictions of these orders for performance of Bank & ATM related duties:-

1. All the Treasury, Currency Chest, CAC, Captive Branches, CRA /CIT Agency Linked Branch, Branch handing Import Export business, BC/ CSP, Controlling Offices, Bank IT offices with minimum limited staff shall be kept open from the 10.00 AM to 5.00 PM. These branches will open only for essential services, ATM Cash replenishment Govt. Business etc, other than above rest of the branches will be kept open from 10.00 AM to 5.00 PM.
2. Only Specified Bank Branches including RBI Chest Branches are permitted to remain open for extended working Hours upto 12.00 Hrs Night for their Annual Closing & Government Business, Special Clearing Purpose Only for 31.03.2020.
3. On 01.04.2020 (Being Bank Holiday) Bank will open only for internal work and normal Bank Working Hours.
4. From 03.04.2020 onwards, Only One Third (1/3) of the Bank Branches shall be opened with Minimum Staff,
5. The Banks shall ensure that the ATMs are operational 24x7 and BCs/CSPs provide services in the rural areas with the security staff and BCs instructed to ensure social distancing and hygiene.

These institutions/officers/employees will follow the instructions / orders issued by Govt. of India/Govt. of Punjab and undersigned regarding the Covid-19. Any violation of these instructions / orders is liable to criminal prosecution.



OFFICE ORDER

In order to break the transmission chain of contagion of COVID-19, undersigned has issued prohibitory orders under section 144 of the Code of Criminal Procedure, 1973 vide endst. No. 5713-99 dated 23-3-2020 vide which restrictions on movement of any person outdoor (curfew) from 23-3-2020 (2.00 PM) till further orders.

WHEREAS, in pursuance of the letter No. FD/IF/2020/SPL/1 dated 24-3-2020 issued by Department of Finance, Govt. of Punjab, following institutions, Banks, CRA & CIT Agencies, officers, employees on production of their official Identity cards are exempted from the restrictions of these orders for performance of Bank / ATM related duties:-

1. All Branches including the Treasury, Currency Chest, CAC, Captive Branches, CRA/CIT Agency Linked Branch, Branch handling Import Export business, BC/CSP, Controlling Offices with minimum limited staff shall be kept open from the 10.00 AM to 05.00 PM. All branches will open only for essential services, ATM Cash replenishment Govt. business and **no public dealing** will be allowed.
2. All the ATMs of every bank shall remain open from 8.0 AM to 8.0 PM.
3. All the Bank Branches in district Bathinda will remain open on 30-03-2020 to 01.04.2020 especially for Annual Closing related work, Agri Intt. Subventions entries of farmers etc with maximum three (3) staff members per branch, Branch Head to issue special Identity Card to staff and the copy of ID card be shared with concerned staff for security purpose. On 01.04.2020 for internal work and staff only.
5. All the concerned officials are directed to ensure social distancing and personal hygiene measures in their branches / ATM i.e. use of sanitizers / masks / gloves.


