Order No. 334/MA

The Curfew was imposed Under Section 144 of the Code of Criminal Procedure, 1973 vide this Office Order No. 212/MA dated 23.03.2020 issued vide Endst. No.1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot with effect from 23.03.2020.

The instructions have been issued by Additional Chief Secretary, Govt. of Punjab, Department of Home Affairs and Justice vide letter no. SS/ACSH/2020/292 dated 13.04.2020 with regard to exemption to spare parts shops and workshops etc., keeping in view the forthcoming procurement of wheat.

Therefore, **I Kumar Saurabh Raj, IAS, District Magistrate, Faridkot** by virtue of the power vested in me under section 144 of the Code of Criminal Procedure, 1973 hereby order that following categories are exempted from Curfew from 07.00 AM to 06.00 PM, till further orders.

- (i) Shops of Agriculture Machinery, its spare parts (including supply chain) and repairs to remain open.
- (ii) Shops for truck repairs on Highways, preferably at fuel pumps to remain open.
- (iii) All petrol pumps shall remain open to cater the Trucks/Tractors involved in the transportation work of wheat procurement.
- (iv) Manufacturing units of packing material for food items, drugs, pharmaceuticals and medical devices, including Ayush drugs.
- (v) Manufacturing and packing units of Fertilizers, Pesticides and Seeds.
- (vi) Intra and inter-state movement of harvesting and sowing related machines like Combine Harvesters and other agricultural/horticultural implements is allowed.
