Order No. 379/MA

The Curfew was imposed Under Section 144 of the Code of Criminal Procedure, 1973 vide this Office Order No. 212/MA dated 23.03.2020 issued vide Endst. No.1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot with effect from 23.03.2020.

The instructions have been issued by the Additional Chief Secretary, Govt. of Punjab, Department of Home Affairs and Justice vide letter no. SS/ACSH/2020/335 & letter No. 337 dated 29.04.2020 with regard to exemption to certain categories in curfew w.e.f 30.04.2020.

The modalities with regard to opening of shops is to be prepared. Therefore, I Kumar Saurabh Raj, IAS, District Magistrate, Faridkot by virtue of the power vested in me under section 144 of the Code of Criminal Procedure, 1973 hereby ordered that Curfew imposed in District Faridkot vide order dated 23.03.2020 shall continue till further orders.

The order regarding opening of shops will be issued by tomorrow evening by taking due care for containment of COVID-19.
