The Curfew was imposed vide order No. 212/MA dated 23.03.2020 issued vide endst. No. 1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot.

Vide this office Order no. 396/MA dated 01.05.2020 issued vide endst. No.2400/MA dated 01.05.2020 for functioning of banking service in District Faridkot.

Whereas in pursuance of the letter No. SS/ACSH/2020/354 dated 03-05-2020 of Government of Punjab, Department of Home affairs and Justice, Chandigarh the following instruction are issued:-

- 1. All the ATMs of every bank shall remain open from 06:00AM to 08:00PM.
- 2. All bank branches shall be continued to open for Public Dealing work from 09.00 AM to 01.00 PM and after that allowed to carry out their non-public office work as per their requirement, as per their normal working hours & working days.
- 3. The bank ID card of banking staff will be considered as curfew pass.
- 4. Taking into account the curfew imposed in the District to tackle with pandemic COVID-19 situation, Police personnel should be deployed at each branch / ATM to handle or control rush of customer's, SSP Faridkot is requested to make proper arrangement for the deployment of police personals at the branches/ATMs of District Faridkot as per roster for banking Service attached herewith.
- 5. All the managers of the banks which will be open during this specified time are directed to ensure all the social distancing and personal hygiene measures in their branches i.e 1 to 1.5 meter distance, use of sanitizers, masks and gloves by the staff, at the branches and ATMs further every branch should have tents and chairs outside the premises for customer facilitation.
