Order No. 432/MA

The Curfew was imposed vide order No. 212/MA dated 23.03.2020 issued vide endst. No. 1587/MA dated 23.03.2020 in territorial jurisdiction of District Faridkot.

Whereas in pursuance of the letter No. 1/4/2020-EB (PR)/203-246 dated 07-05-2020 of Government of Punjab, Department of Power (Power Reforms Wing), Chandigarh the following instruction are issued:-

1. All the Cash collection counters for consumers bills of PSPCL in District Faridkot shall remain open from Monday to Friday timing 09:00AM to 02:00PM.
2. All the meter readers are allowed to resume meter reading from 09:00AM to 02:00PM operations in District Faridkot. All meter readers are directed to wear masks and gloves and maintain social distancing.
3. The Department ID card of PSPCL staff will be considered as curfew pass.
4. Taking into account the curfew imposed in the District to tackle with pandemic COVID-19 situation, Police personnel should be deployed at each cash collection counters to handle or control rush of customer's, SSP Faridkot is requested to make proper arrangement for the deployment of police personals at the cash collection counters for consumers bills of PSPCL.
5. All the XENs, PSPCL in district Faridkot are directed to ensure the social distancing and personal hygiene measures in their branches i.e 1 to 1.5 meter distance, use of sanitizers, masks and gloves by the staff, at the collection counters.
