ORDER

Whereas, to contain the spread of COVID-19, a complete lockdown was announced in the State of Punjab and curfew was imposed in district Amritsar on 23.03.2020.

Whereas, keeping in view the emerging situation of COVID-19 in Amritsar and in light of the guidelines given by Govt. of Punjab, Department of Home Affairs and Justice, vide letter no.SS/ACSH/2020/420 dated 14.05.2020 in order to mitigate hardship to the public,

I, Shivdular Singh Dhillon, IAS, District Magistrate, Amritsar, in continuation of the orders issued vide Endst. No. COVID-19/1191-1213 dated 07.05.2020, allow further relaxations in following activities.

1. Shops are allowed to open from 7:00 AM to 6:00 PM, However in order to ensure that there is no crowding or violation of social distancing norms, The concerned SDMs/DCPs may stagger the opening/closing time of various categories , keeping in view the circumstances in various areas.
2. Those who provide goods through home delivery or e-commerce companies are permitted to work till 8:00 PM.
3. Schools are allowed to distribute books from their premises. The school authorities will ensure that not more than 10 persons will gather to collect books at any time..
4. Establishments dealing with services like Spa, Salon, Parlors, Gyms, Cinemas, Malls, Banquet halls etc. will continue to remain close till further orders.

All Shops Owners/ Managers will be responsible to maintain social distancing, ensure use of masks and sanitizers at and immediately outside their premises.

These relaxations shall not be applicable in the containment zone.

These orders will come into effect from 15.05.2020 and are being issued under the Epidemic Disease Act, 1897 (The Punjab Epidemic Diseases, COVID-19 regulations, 2020) and the Code Of Criminal Procedure, 1973. Any violation of these orders shall attract penal action under the above provisions of law.
