Order

With reference to the letter number SCCR/2020/236 dated 30/4/2020 from state COVID-19 Control room, it is hereby ordered that the District Level Committee (DLC) made vide order COVID-19/266-272 Dated 01/04/2020 for collecting information on migrant labor will get the proforma issued by State Control Room and available at www.covidhelp.punjab.gov.in, filled from each willing person who wants to go out from Punjab. It will ensure adequate teams are made for doing this work. The Committee will work as per following guidelines:-

- a) Once a person has filled the proforma on link for his family/group, he/she will be given system generated unique ID for the full family group.
- b) By 09:00 A.M of 03/05/2020 the district should get complete information filled in the given link by all the interested persons. The link should be given maximum publicity by floating it amongst leaders of migrants and by popularizing it on local media.
- c) The Committee will also identify 10 places in the city area, 2 in each Zone and 2 places in each rural Sub - division so that screening of these people may be done by arranging health check up camps.
- d) Bulk SMSs should be sent informing each person about the date and location of camp where she/he is to be screened. Members of family/group must be screened at one camp itself.
- e) The screening should be completed by 04/05/2020 night at all costs.
- f) Once a person is screened and found asymptomatic he/she will be issued a Certificate by the health team in the format attached as Annexure (A). The DLC will provide staff to the health team for this exercise.
- g) Movement of persons shall start from 05/05/2020.
- h) DLC will create teams which will go to the link www.covidhelp.punjab.gov.in and enter ID of each group/family who leaves the State of Punjab.
