Dear Colleague,

This refers to the ~~conduct of AIIMS Entrance and Recruitment Examination and Nursing Officer Recruitment Common Eligibility Test (NORCET)~~ that were deferred in view of Covid-19. AIIMS-Entrance and Recruitment Examination is now planned to be held on 21st August 2020 and NORCET on 1st September, 2020. The conduct of these examination is necessary to avoid loss of entire academic session causing irreparable harm to career of thousands of brightest medical professionals of our country.

2. AIIMS, New Delhi has taken measures to ensure implementation of the advisory of the Government of India on social distancing and other preventive /protective measures at examination centres. Additional measures have been taken to minimize the travel needs of the candidates by increasing the cities for examination from 10 to 72 for 21st August & 156 cities for 1st September throughout the country. The list of the examination centres is enclosed.

3. May I request you to kindly provide the following support:

- i) ~~AIIMS Entrance & Recruitment Examination~~ to be considered as an essential Activity and be allowed in containment zone also
- ii) The examination centres across the country should be allowed to open and operate for all activities related to preparation and conduct of Examination to be held on 21st August and 1st September 2020.
- iii) ~~Admit Card of AIIMS entrance examination~~ to be considered as equivalent of curfew pass for movement for the purpose of Examination to be held on 21st August and 1st September 2020
- iv) The support staff/observers of AIIMS and Industry Partners (Tata Consultancy Services, Electronic Corporation of India Limited-ECIL) should be permitted to travel for the purpose for preparation and conduct of Examination to be held on 21st August and 1st September 2020

v) Local authorities to provide necessary administrative facilitation and security for conduct of the AIIMS-Entrance Examination on 21st August and 1st September 2020
