BACKGROUND

The prime focus of state government is empowerment of citizens, inclusive growth and all-round development by leveraging administrative reforms and emerging information technology tools. The Department of Governance Reforms is playing a pivotal role in implementation of e-governance initiatives at all administrative levels within the state, specially, in providing public services to the citizens in transparent and efficient manner. As part of Digital Punjab programme, back end computerization for various public services will be completed in 3 to 5 years.

2. *Administrative reforms and e-governance in all Departments of the Government, reports of the Administrative Reforms Commission and*

Punjab Governance Reforms Commission, National e-Governance Programme.

3. *Administration of the Right to Information Act.*
4. *Management of the State Data Centre, State Wide Area Network, State Service Delivery Gateway and related matters.*
5. *Administration and all the matters of the Punjab Right to Service Act,2011 and the Punjab Right to Service Commission.*
6. *To formulate policy on the use of Information Technology in the State of Punjab.*
7. *To formulate and implement a plan for induction of Information Technology at all levels, in coordination with the Government Departments concerned.*
8. *To give Technical advice to all departments regarding adoption of suitable Information Technology Systems for making appropriate arrangements to maintain the service.*

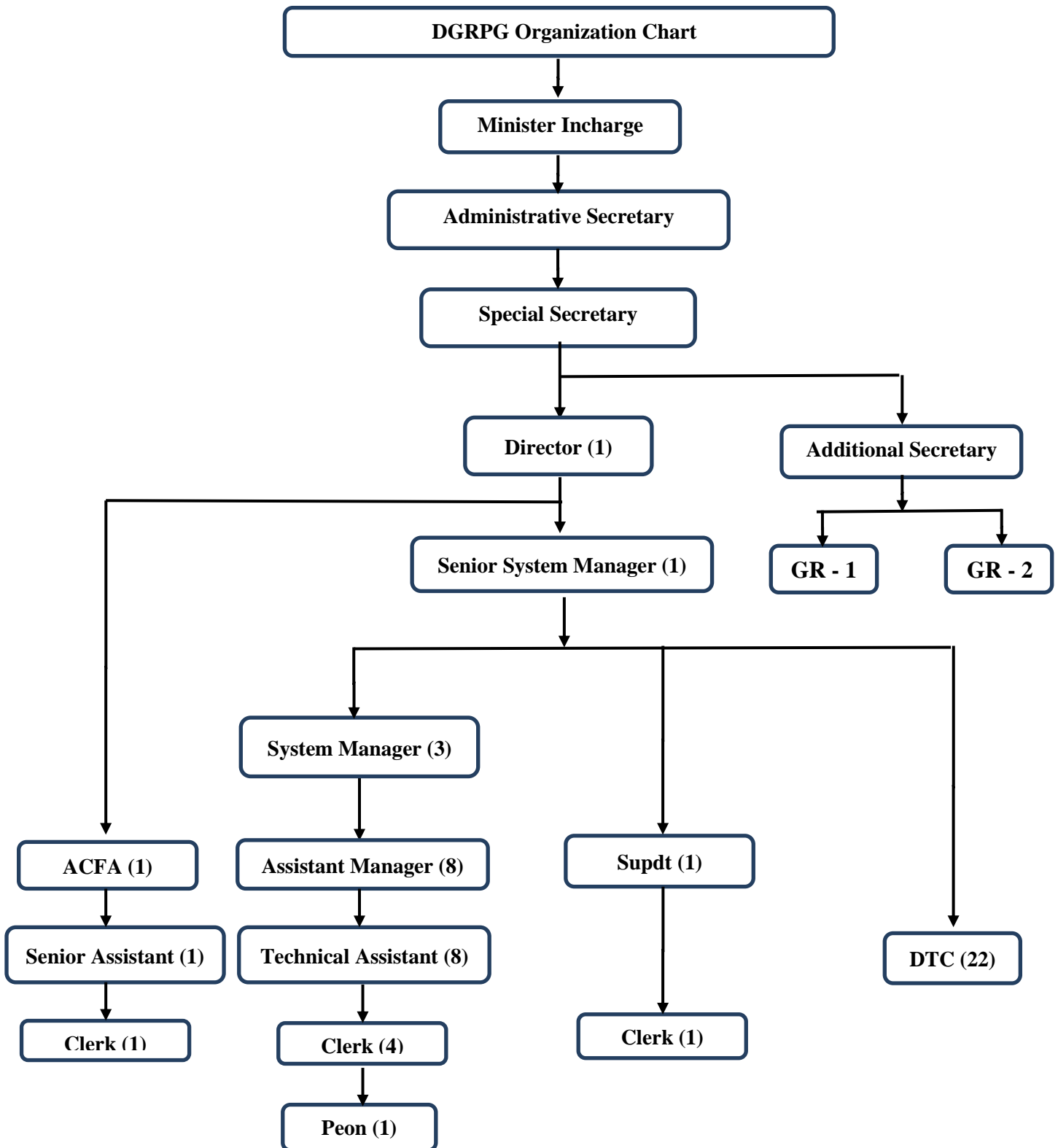
