FIRST ADDENDUM To Memorandum of Understanding dated January 01, 2019 executed between National Informatics Centre Services Incorporated and Punjab State e-Governance Society (under the aegis of Department of Governance Reforms, Government of Punjab) for SMS Gateway Services to GoP through NIC SMS gateway platform

This First Addendum to the Memorandum of Understanding dated January 01, 2019 is made on this 1th September 2024

#### Between

National Informatics Centre Services Incorporated a Company registered under section 25 of the Companies Act, 1956, a Government of India enterprise under NIC, Ministry of Electronics and Information Technology, having its office at 6th Floor Hall No. 2 & 3, 15 NBCC Tower, BhikajiCama Place, New Delhi – 110066 represented by Managing Director through Company Secretary hereinafter referred to as "NICSI" which expression shall unless be repugnant to the context or meaning thereof, amount to include its Successors, Administrators and assigns on the FIRST PART;

### And

**Punjab State e-Governance Society** (under the aegis of Department of Governance Reforms, Government of Punjab) represented by the member Secretary, Punjab State e-Governance Society - Cum- Director, Governance Reforms, Government of Punjab, SAS Nagar, Punjab hereafter referred as "GoP" (which expression shall unless excluded by or repugnant to the context be deemed to include his successor in office) of the **SECOND PART**.

Whereas **NICSI** and **GoP** are individually referred as "Party" and collectively referred as "Parties".

Whereas **NICSI** and **GoP** have executed a Memorandum of Understanding dated January 01, 2019 for the provision of SMS, OBD, Missed-Call including any new services introduced in the scope of the project through NIC SMS gateway platform hereinafter referred to as "**MoU**".

**WHEREAS** the duration of the MoU was valid till January 17, 2024. The Parties now desire to extend the duration of the MoU with the same terms and conditions for which purpose this addendum is being executed (hereinafter referred to as **"First Addendum"**) subject to terms and conditions contained hereinafter.

Now, therefore, in consideration of the mutual promises and the mutual covenants herein contained, the Parties agree as follows:

## 1. Scope of the First Addendum

1.1 This First Addendum to the MoU concerns with the extension of the duration of the MoU for another period of 3 (Three) years from 18.01.2024 to 17.01.2027.

### 2. Amendments

2.1 The duration of the MoU be and is hereby extended for another period of 3 (Three) years from 18.01.2024 to 17.01.2027.

- 3.4. This First Addendum may be executed in two or more identical counterparts, each of which shall be deemed to be an original and all of which taken together shall be deemed to constitute this First Addendum when a duly authorized representative of each Party has signed a counterpart.
- 3.5. This First Addendum shall become an integral part of the MoU and shall together represent the complete understanding between NICSI and GoP with respect to the subject matter hereof.
